

Official Rules - 2019 All-Star Ticket Slam

THE FOLLOWING OFFER IS VALID IN THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA ("D.C.") ONLY, AND IS OPEN ONLY TO QUALIFIED PERSONS (AS DEFINED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED BY LAW.

PROGRAM SUMMARY

The All-Star Ticket Slam (the "Contest") is a property of SecondTicket, LLC (the "Contest Administrator"). Registration begins on 7/1/19 and ends on 7/9/19. For the purposes of this program, the major league baseball All-Star Game at Progressive Field in Cleveland, OH, on July 9, 2019 will hereinafter be referred to as the "Game". The object of the Contest is to accrue points with player predictions and a prediction of the total number of runs, hits and errors in the Game. **First Prize** is a \$100-250 **Mega Credit** depending on the number of Contestants. In addition, all fans are eligible to win up to \$50 in **Mega Credits** from SecondTicket. **Points** based on player predictions and the accuracy of your runs, hits and errors prediction are awarded to determine the **First Prize** winner and also apply to a contestant's participation in The 2019 Mega Pool. This contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited and no purchase necessary.

WHO MAY ENTER AND HOW TO PLAY

Contest is open to legal residents of the 50 United States and District of Columbia ("D.C."), who are age 18 or older as of 7/9/19, have a valid driver's license, and have a SecondTicket account with a valid email address, name, birth date, username and phone number. The following classes of persons are ineligible: employees, officers, and directors of **SecondTicket** ("Administrator") and their spouses.

Between 10:00am ET on 7/1/19 and 6:00pm ET on 7/9/19 (the "Registration Period"), fans with valid SecondTicket accounts may visit win.secondticket.com/all-star-ticket-slam/play.aspx to choose two players from each league (one starting player and one reserve), their "Player Selections", and the total number of runs, hits and errors in the game "RHE Prediction". These selections constitute in full your prediction (hereinafter referred to as "Prediction"). Upon pressing 'Submit', your contest registration will be complete, at which time you will become an official contestant ("Contestant").

Game rosters are subject to change after they have been announced; a change in a player's status as a starter or reserve may result in an invalid Player Selection, so Predictions may be revised at any time during the Registration Period. For example, Contestants who select a reserve player who subsequently becomes a starter receive 0 points for that player unless they modify their Player Selections and choose that player as a starter. SecondTicket is not responsible for invalid Player Selections.

Each Contestant is limited to a maximum of (1) Prediction. Any person submitting multiple Predictions, using either valid or invalid email addresses, will be disqualified. Your Prediction on file with Administrator at the conclusion of the Registration Period shall be your one and only official Prediction. By registering for the Contest, you acknowledge to have read and agreed to its Official Rules.

SCORING FORMULA

Points are awarded in two categories: **Basic** and **Bonus**. Basic Points are awarded in two types of innings: Standard (1st, 3rd, 4th, 5th, 6th, 7th, 9th, and any extra innings, if applicable); and Bonus (2nd, 8th). The sum of a Contestant's Basic and Bonus points equals their Total Points.

1. Basic Points

a. Receive up to 400 Basic Points based on your players' cumulative offensive production according to the schedule below:

- i. Strikeout = -1 point in Standard Innings, -2 points in Bonus Innings
- ii. Double Play = -2 points in Standard Innings, -4 points in Bonus Innings
- iii. Walk = 1 point in Standard Innings, 2 points in Bonus Innings
- iv. Stolen Base = 2 points in Standard Innings, 4 points in Bonus Innings
- v. Runs = 5 points in Standard Innings, 10 points in Bonus Innings
- vi. RBI = 5 points in Standard Innings, 10 points in Bonus Innings
- vii. Single = 10 points in Standard Innings, 20 points in Bonus Innings
- viii. Double = 20 points in Standard Innings, 40 points in Bonus Innings
- ix. Triple = 30 points in Standard Innings, 60 points in Bonus Innings
- x. Home Run = 50 points in Standard Innings, 100 points in Bonus Innings
- xi. Grand Slam = 100 points in Standard Innings, 200 points in Bonus Innings

2. Bonus Points

a. Receive up to 50% of your Basic Points based on the differential between your RHE Prediction and the actual RHE according to the formula below:

For example, 10 Basic Points with an RHE differential of 5 qualifies for 2 Bonus Points; 100 Basic Points with an RHE differential of 5 qualifies for 20 Bonus Points.

PRIZE SCHEDULE

1. **First Prize** is awarded to the Contestant who accrues the most total points during the Contest Period. The amount of the First Prize will be equal to \$1.5 per Contestant, with a minimum of \$100 and a maximum of \$250. For example, First Prize for 50 Contestants is \$100; First Prize for 100 Contestants is \$150; First Prize for 150 Contestants is \$250. First Prize is payable as **Mega Credits** on the Contestant's SecondTicket fan account.

a. In the event of a tie, the Contestant whose RHE Prediction is closest to the actual RHE number, regardless of whether the prediction is higher or lower than the actual number, wins. Second tiebreaker is the highest scoring player; third tiebreaker is the higher scoring lowest scoring player. If multiple Contestants are still tied, First Prize will be evenly split among tied Contestants in no less than \$25 increments.

2. **Mega Credits** will be awarded based on the cumulative offensive performance of a Contestant's Player Selections, up to \$10 per player or \$50 total if a grand slam is hit in a bonus inning:

3. Prize Terms

- a. Only the maximum applicable prize(s) will be awarded. For example, if a player hits a bonus inning grand slam, only the \$50 credit is awarded; no other credits are awarded. Similarly, if a player hits a standard inning grand slam, the \$5 home run credit is not awarded.
- b. A grand slam must be counted as an over-the-fence or inside-the-park home run with runners on all three bases and no errors committed in the official statistics of Major League Baseball.
- c. If the Game is cancelled and not rescheduled for any reason prior to becoming an official game, all statistics are erased from the official score book and no prizes will be awarded.

All **Mega Credits** will be placed on the Contestant's SecondTicket fan account at the conclusion of the Game and are subject to the terms and conditions of credit usage at www.secondticket.com/ticket-credit-terms-and-conditions. Mega Credits issued as First Prize have no expiration date. All others are valid through January 31, 2020.

ADDITIONAL RULES & RESTRICTIONS

By participating in this contest, you agree to abide by, and be bound by, the Official Rules and the decisions of the Administrator, which shall be final in all Contest matters. Participation in Contest constitutes permission for the Administrator to solicit personal information related to your live entertainment and gaming preferences, including but not limited to teams, artists, shows, fantasy sports and office pools, for use in online, email and social media marketing purposes and to use winners' names and/or likenesses for purposes of advertising and trade in any media worldwide without limitation or further compensation unless prohibited by law.

Ticket credits will be placed on the contestant's fan account and be available for redemption immediately. In the event of a Grand Prize winner, prize awards are subject to verification and compliance with these Official Rules. Prize winner(s) must accept delivery of prize from Sponsor, or as otherwise instructed by sponsor. Winners of prizes greater than \$600.00 will be issued a 1099 form reflecting the value of the prize(s) and are responsible for paying all income taxes on prize(s). Failure to collect or properly claim any prize in accordance with these rules will result in forfeiture of the prize. In the event of a dispute as to any on-line registration, the authorized account holder of the e-mail address used to register will be deemed to be the registrant. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. All entries received become the property of the Sponsor and will not be returned.

IN CASE OF DISPUTES

Odds: The odds of a grand slam are approximately 20:1. The odds of winning First Prize are based on a Contestant's knowledge of professional baseball relative to other eligible contestants.
