PROMOTION SUMMARY

The Bracket Challenge Ticket Jam (the "Contest") is a property of SecondTicket, LLC. The Contest begins on 3/18/19 and ends on 4/8/18 (the "Contest Period"). For the purposes of this Contest, rounds 1-6 of the collegiate Division I men's basketball tournament to be played in various cities and concluding in Minneapolis, MN between 3/21/19 and 4/8/19 will hereinafter be referred to as the "Tournament". The object of the Contest is to accrue points with correct Tournament Game and Score Predictions. First Prize is a \$100-250 Mega Credit depending on the number of Contestants. Fans who do not win First Prize are eligible to win up to \$100 in Mega Credits. Points based on prediction accuracy are awarded to determine the pool's leaderboard and also apply to a contestant's standing in The 2019 Mega Pool. This contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited and no purchase necessary.

WHO MAY ENTER AND HOW TO PLAY

Contest is open to legal residents of the 50 United States and District of Columbia ("D.C."), who are age 18 or older as of 3/21/19 have a valid driver's license, and have a SecondTicket account with a valid email address, name, birth date, username and phone number. The following classes of persons are ineligible: employees, officers, and directors of SecondTicket ("Administrator") and their spouses.

Between 12:01am ET on 3/18/19 and 12:00pm ET on 3/21/19 (the "Registration Period"), fans with valid SecondTicket accounts may visit win.secondticket//brackethallenge-ticket-jam/play.aspx to enter their "Game Predictions" of the winning teams of all 63 Tournament games. You will receive an email confirming receipt of your Game Predictions, at which time you become an official contestant ("Contestant"). Beginning on 4/1/19, Contestants may return to submit "Score Predictions" of the final scores of three games: the Tournament's two semifinal games and one championship game. Semifinal score predictions must be submitted before the beginning of the first semifinal game on 4/6/19 and championship game score predictions must be submitted by 8:30pm ET on 4/8/19. In no event may any Game or Score Prediction be submitted or changed after its respective deadline. Any bracket with incomplete or illegible predictions will result in the minimum number of points for those games and Administrator disclaims all liability for such submissions. All predictions are time stamped and may be revised any time before the end of their respective deadline; any such revisions result in a new time stamp.

A Contestant's "Game Predictions" and "Score Predictions" constitute in full a Contestant's "Contest Entry"; each Contestant is limited to a maximum of (1) Contest Entry. Any person submitting multiple Contest Entries (or Game Predictions or Score Predictions), using either valid or invalid email addresses, will be disqualified. Your Game and Score Predictions on file with Administrator as of their respective deadlines shall be your one and only official Contest Entry. By registering for the Contest, you acknowledge to have read and agreed to its Official Rules.

SCORING FORMULA

Points are accrued with Game Predictions (submitted by 3/21) and Score Predictions (submitted between 4/1 and 4/8):

- Game Prediction Points Earned by picking the winning team in each of the 63 games of the Tournament:
 - 1-2 points for each correct 1st round prediction (32 games on 3/21 & 3/22/19)
 - 1 point for the 1 vs. 16 games
 - 1.1 points for the 2 vs. 15 games
 - 1.2 points for the 3 vs. 14 games
 - 1.4 points for the 4 vs. 13 games
 - 2-3 points for each correct 2nd round prediction (16 games on 3/23 & 3/24/19) 2 points for the 1/16 vs. 8/9 games
 - 2.2 points for the 2/16 vs. 7/10 games
 - 8 points for each correct 3rd round prediction (eight games on 3/28 & 3/29/19)
 - 12.5 points for each correct 4th round prediction (four games on 3/30 & 3/31/19)
 - 20 points for each correct 5th round prediction (two semifinal games on 4/6/19)
 - 30 points for a correct 6th round prediction (one championship game on 4/8/19)
- Score Prediction Points Earned by predicting the final scores of the last three games of the Tournament:
 - 1 point for a prediction within 10 points of a team's score 2 points for a prediction within 9 points of a team's score
 - 3 points for a prediction within 8 points of a team's score C.
 - 4 points for a prediction within 7 points of a team's score
 - 5 points for a prediction within 6 points of a team's score
 - 6 points for a prediction within 5 points of a team's score
 - 7 points for a prediction within 4 points of a team's score
- 8 points for a prediction within 3 points of a team's score
- i. 9 points for a prediction within 2 points of a team's score
- 10 points for a prediction within 1 point of a team's score j.
- 25 points for matching the exact final score of one team
- 50 points for matching the exact final score of both teams in the same game 1
- m. Match any three of six final scores for 100 total points
- Match all six final scores for 150 total points

1.6 points for the 5 vs. 12 games

1.8 points for the 6 vs. 11 games

1.9 points for the 7 vs. 10 games

2.8 points for the 3/14 vs. 6/11 games

3 points for the 4/13 vs. 5/12 games

2 points for the 8 vs. 9 games

- First Prize is awarded to the Contestant who accrues the most total points during the Contest Period. The amount of the First Prize will be equal to \$1.00 per Contest Contestant, with a minimum of \$100 and a maximum of \$250. For example, First Prize for 75 Contestants is \$100; First Prize for 200 Contestants is \$200; First Prize for 300 participants is \$250. First Prize is awarded as a Mega Credit on the Contestant's SecondTicket fan account.
- **Prediction Awards**
 - In rounds one through four, Mega Credits will be awarded to the Contestants with each round's best Game Predictions:
 - 1st Round top 25% plus ties = \$2 per Contestant
 - 2nd Round top 25% plus ties = \$1 per Contestant
 - 3rd Round top 25% plus ties = \$1 per Contestant
 - 4th Round top 25% plus ties = \$1 per Contestant
 - In rounds five and six, Mega Credits will be awarded based on Score Predictions:
 - \$2 for a final score prediction within 1-4 points of one team
 - \$5 for matching the exact final score of one team, or \$25 for matching the exact final score of both teams, in a semifinal game
 - \$5 for matching the exact final score of one team, or \$50 for matching the exact final score of both teams, in the championship game

For a Score Prediction to be eligible for any point or prize award, the Prediction must match the exact final score of the designated team(s). If the actual final score is Team A: 75, Team B: 65, then a predicted score of Team B: 75, Team A: 65 or a prediction of 75-65 without specifying the teams is incorrect.

- First Prize а
 - Score prediction closest to the score of the winning team in the championship game
 - Prediction of total points in the championship game closest to the actual number of points

- v. Earliest submission of Game Predictions by date and time received

- All Mega Credits will be placed on the Contestant's SecondTicket fan account at the conclusion of each respective round and are subject to terms and conditions at www.secondticket.com/ticket-credit-terms-and-conditions. Mega Credits issued as First Prizes have no expiration date. All others are valid through October 31, 2019.

ADDITIONAL RULES & RESTRICTIONS

By participating in this contest, you agree to abide by, and be bound by, the Official Rules and the decisions of the Administrator, which shall be final in all Contest matters.
