Official Rules – 2019 Monday Night Ticket Score

CONTEST SUMMARY

The 2019 Monday Night Ticket Score (the "Contest") is a property of SecondTicket, LLC. The object of the Contest is to guess the exact final score of one designated professional football game per week to earn points and awards based on the accuracy of the guess. Points are accrued on a weekly, quarterly, and season basis. The Contest begins on 9/9/19, ends on 12/23/19, and encompasses (16) games of the professional football season (the "Contest Period"). The competition is divided into (4) quarters: Q1 (weeks 1-4, 9/9 to 9/30), Q2 (weeks 5-8, 10/7 to 10/28), Q3 (weeks 9-12, 11/4 to 11/25), and Q4 (weeks 13-16, 12/2 to 12/23/19). **Grand Prize** is \$200-\$500 (depending on the number of Predictions) plus the chance to win \$10,000. Four **Quarterly Prizes** of \$10-25 (depending on the number of quarterly Predictions) will be awarded. All officially registered Contestants will also be eligible to win **First Prize** and **Weekly Prizes** (see Prize Schedule). Contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited and no purchase necessary.

WHO MAY ENTER AND HOW TO PLAY

Contest is open to legal residents of the 50 United States and District of Columbia ("D.C."), who are age 18 or older as of each individual game date, have a valid driver's license, and have a SecondTicket account with a valid email address, name, birth date, username and phone number. The following classes of persons are ineligible: employees, officers, and directors of **SecondTicket** ("Administrator") and their spouses. Contestants are limited to a maximum of (1) Prediction per week; persons with multiple SecondTicket accounts may submit Predictions only under one account. Additional Predictions submitted by any person under any multiple account, using either valid or invalid email addresses, will be disqualified and may subject that person to Contest disqualification.

Between 10:00am ET on Tuesday, September 3, 2019 and the conclusion of the Contest Period, eligible fans with valid SecondTicket accounts may visit win.secondticket.com/monday-night-ticket-score/play.aspx to enter a final score prediction of the next designated game in the Game Schedule (below). Score predictions must be a numeric value between 0 and 99 for each team. Submission of a score in any other format, such as 'twenty-one' or 21-10, is invalid. These two scores constitute a weekly prediction (the "Prediction"). You will receive an email confirming receipt of each Prediction or revision thereof; upon receipt of your first confirmation email, you will become an official contestant ("Contestant"). By submitting a Prediction, you acknowledge to have read, and agreed to, these Official Rules.

GAME SCHEDULE

The following schedule identifies the professional football games in the Contest and their corresponding Prediction Deadlines. Predictions may be submitted or changed beginning at 12:01 AM ET on the Tuesday prior to the Game Date (the lone exception being Week 1). In no event may a Prediction be submitted or changed after the weekly Prediction Deadline. A Contestant's Prediction on file with Administrator as of the Prediction Deadline shall be their one and only official Prediction for the week.

*Monday Night Football is not played during week 17 of the professional football season.

score/leaderboard/weekly.aspx?id=147week=x. At the conclusion of each week's game, weekly results and updated overall standings will be posted.

SCORING FORMULA

Points are awarded in two categories: Differential and Match, with a Winning Team Multiplier applied for picking the correct team to win.

- 1. <u>Differential Points</u> a. Receive betw
 - Receive between 1 and 25 Differential points for a score prediction within 3 points of a team's actual final score according to the schedule below:
 - i. Exact match of a team's score = 25 points

- iv. Prediction within 3 points of a team's score = 10 points
- ii. Prediction within 1 point of a team's score = 20 points
- v. Prediction with a differential of 4 points or more = 0 points
- iii. Prediction within 2 points of a team's score = 15 points
- b. In the event no fans predict within (3) points of either team, fans who correctly picked the winning team receive 5 points. (See #3, below)

2. Match Points

a. Correctly match a team's score to receive 1-100 Match points based on the actual score's probability, according to the following table:

3. Winning Team Multiplier

A multiplier of up to 5x is applied to the sum of your Differential and Match points for picking the correct winning team, as follows:

i. The number of weekly Contestants divided by the number of weekly Contestants who picked the correct winning team.

- 1. Of 100 contestants, 90 pick Team A to win. 100 / 90 = 1.11x multiplier. If you correctly picked Team A to win and your hypothetical sum of Differential and Match points is 30, 30 is multiplied by 1.11 = 33.3 total points.
- 2. Of 100 contestants, 10 pick Team B to win. 100 / 10 = 10x. The maximum multiplier is 5x. If you correctly picked Team B to win and your hypothetical sum of Differential and Match points is 30, 30 is multiplied by 5 = 150 points.
- 3. When no fan(s) predict within 3 points of either team, points awarded to fans who picked the winning team are not subject to the multiplier.

PRIZE SCHEDULE

- Grand Prize is a variable amount of \$200-\$500, payable as Mega Credits on the Contestant's SecondTicket fan account, and an automatic berth among winners of First Prize (see Prize Schedule, Item 3). It will be awarded to the Contestant who accrues the most total points during the Contest Period. The amount of the Grand Prize will be equal to \$0.15 per Prediction received during the Contest, with a minimum of \$200 and a maximum of \$500. For example, the award for 1,000 Predictions is \$200, for 2,000 Predictions is \$300, and for 4,000 Predictions is \$500. A maximum of (1) Grand Prize will be awarded.
- 2. Quarterly Prize is a variable amount of \$10-\$25, payable as Mega Credits on the Contestant's SecondTicket fan account, and a preferred qualifying position for First Prize (see Prize Schedule, Item 3). A total of (4) Quarterly Prizes will be awarded, (1) to each Contestant who accrues the most points during each quarter of the Contest. The amount of the Quarterly Prize will be equal to \$0.05 per quarterly Prediction, with a minimum of \$10 and a maximum of \$25. For example, the award for 300 Predictions is \$15, for 450 Predictions is \$22.5, and for 600 Predictions is \$25.
- 3. First Prize is the chance to win the following cash prizes by correctly predicting the following scores of the professional football championship game in Miami, FL on February 2, 2020:
 - a. Halftime Score Only = \$100
 - b. Final Score Only = \$1,000
 - c. Halftime and Final Scores = \$10,000

First Prize winners' \$10,000 predictions are separate from Predictions submitted during the Contest Period. If none of the (10) First Prize winners correctly predict any of the scores above, then the corresponding prizes <u>will not be awarded</u>. The (10) First Prize winners will be selected according to the following schedule (a Contestant may not qualify for more than one First Prize berth):

- d. 1 Season Winner
- e. 0-4 Quarterly Winners who did not win the Season
- f. 5-9 Weekly Winners with the highest one-week point totals who did not win a Quarter or the Season. Any fan who posts more than one of the highest eligible one-week totals receives only one First Prize berth and the Weekly Winner with the next highest score qualifies.
- 4. Weekly Prizes up to a total of \$50, payable as Mega Credits, will be awarded to the week's top five (5) fans based on points earned. If more than five (5) fans tie for one or more positions among the top (5), the cutoff is determined by the date and time received of each entry, with the earliest entry qualifying. ONLY five fans will win Weekly Prizes. Each of those five fans wins a Mega Credit proportionate to their percentage of points earned by those five fans. For example: a. Scenario I (more than five fans predict within three points of at least one team):
 - Fans 1-5 score 100, 80, 60, 40 points and 20 points, for a total of 300 points. Fan 1's 100 points account for 33% of the total, earning Fan 1 \$17 in **Mega Credits.** Fan 2 wins \$13, Fan 3 wins \$10, Fan 4 wins \$7 and Fan 5 wins \$3. (All values are rounded to the nearest dollar.)
 - ii. Fan 6 also scores 20 points but the entry is received after Fan 5's entry and is not eligible for a weekly prize.
 - Scenario II (between one and four fans predict within three points of either team):
 - i. Fans 1 and 2 score 30 and 10 points. All remaining fans score 0 points. Fan 1 wins \$38 Mega Credits; Fan 2 wins \$12.
 - c. Scenario III (zero fans predict within three points of either team):
 - i. The first five fans who submitted a prediction with the correct winning team receive \$10 each in Mega Credits.

5. Tiebreakers

b.

- a. Quarterly or Season: Most Weekly Points in the final week of the designated period, then 2nd to last week, etc., then random selection. Any Contestant who did not play in a given week is considered to have 0 Weekly Points.
- b. Weekly Winner: Earliest submission by date & time received, then random selection. Submission times will be posted with Contestant Predictions.
- c. Weekly Winner First Prize berth: Highest season point total, then the highest Q4, Q3, Q2 or Q1 point totals, then random selection.
- All Mega Credits will be placed on the Contestant's SecondTicket fan account at the conclusion of each week's Game and are subject to the terms and conditions of credit usage at <u>www.secondticket.com/ticket-credit-terms-and-conditions</u>. Mega Credits issued as First Prize have no expiration date. All others are valid through June 30, 2020.

7. ADDITIONAL RULES & RESTRICTIONS

FINALIST NOTIFICATION & PRIZE DELIVERY: Prize winners will be notified by Administrator within 48 hours of conclusion of the weekly contest. Ticket credits will be placed on the Contestant's fan account and be available for redemption immediately. Grand and First Prize winners will be notified between 12/24/19 and 2/2/20 to obtain their official \$10,000 score prediction, the final version of which must be submitted to SecondTicket no later than 12:00pm ET on 2/2/20. Unsuccessful attempts to reach Contestant by phone and/or email will result in disqualification and an alternate finalist will be chosen in order of total Contest points. The deadline for alternate Contestants is 4:00pm ET on 2/2/20. Predictions must be clear, legible and complete or they may be disqualified and ineligible for the \$10,000 prize. A maximum of (1) \$10,000 prize will be awarded for a maximum aggregate payout of \$10,000 (split evenly among winners in the event more than one Contestant wins with the same halftime and final scores). In the event of a Conditional Prize winner, prize awards are subject to verification and compliance with these Official Rules. Prize winner(s) must accept delivery of prize from Sponsor, or as otherwise instructed by sponsor. All other costs related to prize delivery and acceptance are the responsibility of winner including but not limited to taxes. All properly claimed prizes will be awarded. Prizes are non-transferable and no cash redemption or prize exceeds \$600, the Contestant will be required to complete and return a W-9 form, affidavit of eligibility, and liability/publicity release (*Tennessee residents need not sign publicity release*), and present a valid driver's license and social security card before prize will be awarded. Winners of prizes greater than \$600.00 will be issued a 1099 form reflecting the value of the prize(s) and are responsible for paying all income taxes on prize(s). Failure to collect or properly claim any prize in accordance with these rules will result in forfeiture of the prize

By participating in this contest, Contestants agree to abide by and be bound by the Official Rules and the decisions of the Administrator, which shall be final in all matters relating to this Contest. If any selected finalist does not meet the eligibility requirements, is unable or unwilling to participate in the grand prize contest, or elects to decline to participate, s/he will be disqualified, and an alternate finalist will be randomly selected from among all remaining eligible entries and notified as per the procedures outlined above. False, fraudulent or deceptive entries or acts shall render Contestants ineligible for any prize. Any disqualified Contestant will not receive any alternate prize substitution or compensation.

connections. Each participant must submit an entry on their own behalf.
