

## Official Rules – 2020 WayCool Super Ticket Pool

**THE FOLLOWING OFFER IS VALID IN THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA (“D.C.”) ONLY, AND IS OPEN ONLY TO QUALIFIED PERSONS (AS DEFINED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED BY LAW.**

### PROMOTION SUMMARY

The 2020 WayCool Super Ticket Pool (the “Contest”) is a property of SecondTicket, LLC which begins on 1/20/20 and ends on 2/2/20 (the “Contest Period”). For the purposes of this Promotion, the professional football championship game at Hard Rock Stadium in Miami Gardens, FL on 2/2/20 will hereinafter be referred to as the “Game”. The object of the Contest is to submit the most accurate prediction of the Game’s coin toss, first scoring play, and final score. The **Grand Prize** is a conditional \$500 **Mega Credit**. **First Prize** is a \$100-250 **Mega Credit** depending on the number of Contestants. Fans who do not win First Prize or Grand Prize are also eligible to win up to \$20 in **Mega Credits**. Points based on prediction accuracy are awarded to determine the pool’s leaderboard and winners. This contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited and no purchase necessary.

### WHO MAY ENTER AND HOW TO PLAY

Contest is open to legal residents of the 50 United States and District of Columbia (“D.C.”), who are age 18 or older as of 1/20/20, have a valid driver’s license, and have a SecondTicket account with a valid email address, name, birth date, username and phone number. The following classes of persons are ineligible: employees, officers, and directors of **SecondTicket** (“Administrator”) and their spouses.

Between 9:00am ET on 1/20/20 and 6:00pm ET on 2/2/20 (the “Deadline”), eligible fans with SecondTicket accounts may visit [win.secondticket.com/way-cool-super-ticket-pool/play.aspx](http://win.secondticket.com/way-cool-super-ticket-pool/play.aspx) to enter their predictions of five Game components: A) Coin toss, B) First team to score, C) Type of first scoring play, D) Minute of first scoring play, and E) Final score of each team. These five predictions are time stamped and constitute in full the Contestant’s prediction (“Prediction”). Predictions may be revised any time before the Deadline; any such revisions result in a new time stamp. In no event may a Prediction be submitted or changed after the Deadline. You will receive an email confirming receipt of your Prediction or revision thereof (“Contestant”). Contestants are limited to a maximum of (1) Prediction regardless of the number of SecondTicket fan accounts held by that person. Any person registering multiple times and/or submitting multiple Predictions, using either valid or invalid email addresses, will be disqualified. A Contestant’s Prediction on file with Administrator as of the Deadline shall be their one and only official Prediction.

### SCORING FORMULA

The maximum number of available base points is 198 (#s 1-5 below), with a Winning Team Multiplier (#6 below):

1. **Coin Toss = 4 points for a correct pick**
  - a. Heads
  - b. Tails
2. **First Team to Score = 4 points for a correct pick**
  - a. AFC Team
  - b. NFC Team
3. **Type of First Scoring Play = 5 – 35 points for a correct pick**
  - a. Defense / Special Teams (35 points)
  - b. Field Goal (5 points)
  - c. Passing Touchdown (6 points)
  - d. Rushing Touchdown (11.0 points)
4. **Minute of First Scoring Play = 17 – 55 points for a correct pick**
  - a. 1<sup>st</sup> Quarter, 1<sup>st</sup> Minute; 14:59 – 14:00 on game clock (54 points)
  - b. 1<sup>st</sup> Quarter, 2<sup>nd</sup> Minute; 13:59 – 13:00 on game clock (39 points)
  - c. 1<sup>st</sup> Quarter, 3<sup>rd</sup> Minute; 12:59 – 12:00 on game clock (32 points)
  - d. 1<sup>st</sup> Quarter, 4<sup>th</sup> Minute; 11:59 – 11:00 on game clock (22 points)
  - e. 1<sup>st</sup> Quarter, 5<sup>th</sup> Minute; 10:59 – 10:00 on game clock (19 points)
  - f. 1<sup>st</sup> Quarter, 6<sup>th</sup> Minute; 9:59 – 9:00 on game clock (17 points)
  - g. 1<sup>st</sup> Quarter, 7<sup>th</sup> Minute; 8:59 – 8:00 on game clock (20 points)
  - h. 1<sup>st</sup> Quarter, 8<sup>th</sup> Minute; 7:59 – 7:00 on game clock (21 points)
  - i. 1<sup>st</sup> Quarter, 9<sup>th</sup> Minute; 6:59 – 6:00 on game clock (33 points)
  - j. 1<sup>st</sup> Quarter, 10<sup>th</sup> Minute; 5:59 – 5:00 on game clock (47 points)
  - k. 1<sup>st</sup> Quarter, 11<sup>th</sup> Minute; 4:59 – 4:00 on game clock (45 points)
  - l. 1<sup>st</sup> Quarter, 12<sup>th</sup> Minute; 3:59 – 3:00 on game clock (44 points)
  - m. 1<sup>st</sup> Quarter, 13<sup>th</sup> Minute; 2:59 – 2:00 on game clock (43.5 points)
  - n. 1<sup>st</sup> Quarter, 14<sup>th</sup> Minute; 1:59 – 1:00 on game clock (50 points)
  - o. 1<sup>st</sup> Quarter, 15<sup>th</sup> Minute; 0:59 – 0:00 on game clock (55 points)
  - p. Anytime after the 1<sup>st</sup> quarter (24 points)
5. **Final Score of Each Team according to the following schedule (0 - 100 points):**
  - a. Exact match of a team’s score = 50 points
  - b. Prediction within 1 point of a team’s score = 24.6 points
  - c. Prediction within 2 points of a team’s score = 19 points
  - d. Prediction within 3 points of a team’s score = 12 points
  - e. Prediction within 4 points of a team’s score = 9 points
  - f. Prediction within 5 points of a team’s score = 8.2 points
  - g. Prediction within 6 points of a team’s score = 7 points
  - h. Prediction within 7 points of a team’s score = 5.8 points
  - i. Prediction within 8 points of a team’s score = 5.4 points
  - j. Prediction within 9 points of a team’s score = 5.2 points
  - k. Prediction within 10 points of a team’s score = 5 points
  - l. Prediction within 11 points of a team’s score = 4 points
  - m. Prediction within 12 points of a team’s score = 3.6 points
  - n. Prediction within 13 points of a team’s score = 3.2 points
  - o. Prediction within 14 points of a team’s score = 3 points
  - p. Prediction within 15 points of a team’s score = 2.8 points
  - q. Prediction within 16 points of a team’s score = 2.6 points
  - r. Prediction within 17 points of a team’s score = 2.4 points
  - s. Prediction within 18 points of a team’s score = 2 point
  - t. Prediction within 19 points of a team’s score = 1.8 points
  - u. Prediction within 20 points of a team’s score = 1.4 points
  - v. Prediction within 21 points of a team’s score = 1 point
6. **Winning Team Multiplier (the sum of your base points multiplied as follows):**
  - a. The number of Contestants divided by the number of Contestants who picked the correct winning team. Using a hypothetical pool of 100 Contestants and 50 base points:
    - i. 80 pick Team A to win.  $100 / 80 = 1.25x$  multiplier.  $50 \times 1.25 = 62.5$  total points
    - ii. 20 pick Team B to win.  $100 / 20 = 5x$  multiplier.  $50 \times 5 = 250$  total points

### PRIZE SCHEDULE

1. The **Grand Prize** is a conditional \$500 **Mega Credit** to be awarded to any Contestant who correctly predicts all five Game components, maximum (2) Grand Prize winners. If no eligible Contestant predicts all five components, the grand prize will not be awarded. If more than one Contestant correctly predicts all five Game components, \$500 in **Mega Credits** will be evenly divided among those Contestants.
2. In the event that the Grand Prize is not awarded, the Contestant who accrues the most points according to the Scoring Formula (above) wins a variable **First Prize Mega Credit** between \$100-250. The First Prize amount will be equal to \$1.00 per Contest Contestant, with a minimum of \$100 and a maximum of \$250. For example, First Prize for 75 Contestants is \$100; First Prize for 200 participants is \$200; First Prize for 300 participants is \$250.
3. **Mega Credits** will be awarded according to the following schedule:
  - a. Result of the Coin Toss (\$1)
  - b. First Team to Score (\$1)
  - c. Type of First Scoring Play (\$1)
  - d. Minute of First Scoring Play (\$1)
  - e. Final Score of Each Team
    - i. \$8 for matching a team’s exact final score
    - ii. \$3 for a prediction within 1-3 points
    - iii. \$2 for a prediction within 4-6 points
    - iv. \$1 for a prediction within 7-10 points
4. Tiebreakers

- a. First Prize
  - i. Earliest submission by date and time received, even if multiple Contestants have correctly predicted all five Game components. All Contestant Predictions and submission times will be posted prior to the Game.
  - ii. In the event multiple Contestants are still tied, the award will be evenly split and distributed.

All **Mega Credits** will be placed on the Contestant's SecondTicket fan account at the conclusion of the Game and are subject to terms and conditions at [www.secondticket.com/ticket-credit-terms-and-conditions](http://www.secondticket.com/ticket-credit-terms-and-conditions). **Mega Credits** issued as Grand or First Prizes have no expiration date. All others are valid through January 31, 2021.

### **ADDITIONAL RULES & RESTRICTIONS**

By participating in this contest, you agree to abide by, and be bound by, the Official Rules and the decisions of the Administrator, which shall be final in all Contest matters. Participation in Contest constitutes permission for the Administrator to solicit personal information related to your live entertainment and gaming preferences, including but not limited to teams, artists, shows, fantasy sports and office pools, for use in online, email and social media marketing purposes and to use winners' names and/or likenesses for purposes of advertising and trade in any media worldwide without limitation or further compensation unless prohibited by law.

Ticket credits will be placed on the contestant's fan account and be available for redemption immediately. In the event of a Grand Prize winner, prize awards are subject to verification and compliance with these Official Rules. No mechanically reproduced or automated entries permitted. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any on-line registration, the authorized account holder of the e-mail address used to register will be deemed to be the registrant. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. All entries received become the property of the Sponsor and will not be returned.

Releasees shall not be liable to any winner, entrant or any other person for failure to supply the prize or any part thereof by reason of any acts of God, any actions, regulations, orders, or requests by any governmental entity, equipment failure, terrorist acts, war, fire, unusually severe weather, embargo, labor dispute or strike, labor or material shortage, transportation interruption of any kind, or any other cause beyond Releasees' sole control. No more than the advertised maximum number of prizes will be awarded for any reason.

### **IN CASE OF DISPUTES**

By participating, each entrant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with this Promotion, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall take place in a federal or state court within the State of New Jersey; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **Odds:** The odds of winning the Grand Prize are approximately 1:16,800. Odds of winning First Prize or Basic Credits are based on a contestant's knowledge of professional football relative to other contestants.
